### Supporting evidence-informed policy making for Universal Health Coverage (UHC) ...

The **effectiveness** of strategic policy decisions depends heavily on timely evaluation, research and monitoring. To guide the strategic design and implementation of the world's largest health assurance scheme, Pradhan Mantri Jan Arogya Yojana (PM-JAY), GIZ conducts **research and evaluation tailored to the policy makers' needs** and ensures a gender lens in all IGUHC research projects.

### ... through research, monitoring, learning and evaluation

IGUHC's research and evaluation component uses a **policy-driven approach, focused on research utilisation**, to advise the government on strategic planning and the implementation of PM-JAY. This means that the national and state **policy makers and**

**implementation partners are the primary target group** for utilising the research findings. Through a **participatory approach**, relevant stakeholders are constantly involved in the research process to identify research areas that are most relevant to them.

**Further, PM-JAY has monitoring and evaluation systems** in place to potentially make mid-course adjustment and to provide information for future strategic directions of the scheme.

The **strong research capacities and structures allow IGUHC to respond to unforeseen challenges** and developments, the latest example being the COVID-19 pandemic.

### Objective

To establish a strong evidence base, through **policy-driven and utilisation-focused research**, monitoring and knowledge management, to **transform findings into strategic policy decisions**.

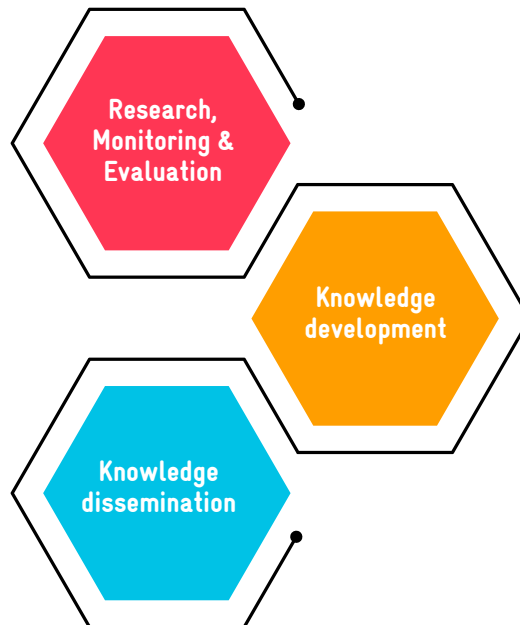
